

GOLF - SOCIAL - DINING



GOLF MEMBERSHIP

Initiation Fee \$50,000 | Annual Dues \$14,900 (taxable)
A Golf member is entitled to unlimited use of all the golf,
and social facilities of the club.

- Golf Members are entitled to unlimited access to golf, dining & social privileges at the Club and have unlimited access to the practice facility year round.
- Golf Members are afforded seven-day advance starting time privileges, with payment of cart fees only.
- During the summer months from May 1st through October 31st, Golf Members have access as a Golf Member to local reciprocal clubs.
- Houseguests can use your same privileges when you are not here, with payment of guest fees.
- Food minimum and Golf Usage Fees apply

SOCIAL MEMBERSHIP

(Limited Golf)

Initiation Fee \$10,000 | Annual Dues \$4,750 (taxable) A Social Member is entitled to all the social facilities of the club & limited use of the golf facilities.

- Social Members are entitled to Dining & Social privileges and have unlimited access to the practice facility year round.
- From November 1st through April 30th, Social Members are allowed to play golf six times per membership. Play is subject to available starting times; and the payment of greens fees and cart fees, and are afforded three day advance starting time privileges.
- From May 1st through October 31st, Social Members may play unlimited golf for a Member Cart Fee and have full access to the Clubs reciprocal program.
- Food minimum and Golf Usage Fees apply





ANNUAL DINING MEMBERSHIP

\$1,400 for a calendar year

Entitled to all Dining & Social privileges, no food minimum, no access to practice facility or golf.

Annual dues are subject to 7% sales tax
